The true and actual consideration for this conveyance is \$43,000.00.

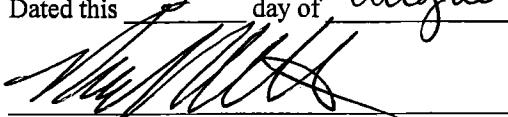

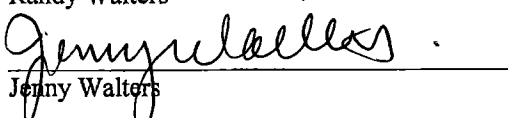

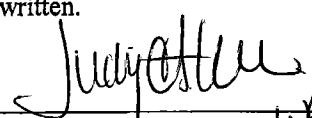
