THIS INDENTURE, made 8/12/2019, between CLEAR RECON CORP, hereinafter called trustee, and THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A., NOT IN ITS INDIVIDUAL CAPACITY, BUT SOLELY AS TRUSTEE OF NRZ PASS-THOUGH TRUST EBO I FOR THE BENEFIT OF THE HOLDERS OF THE SERIES 2017-2, hereinafter called the second party:

WITNESSETH:

RECITALS: NATHAN K ZETTEL AND AMANDA M ZETTEL, AS TENANTS BY THE ENTIRETY, as grantor, executed and delivered to NATIONAL TITLE NETWORK, for the benefit of MORTGAGE ELECTRONIC REGISTRATION SYSTEMS INC., SOLELY AS NOMINEE FOR MOUNTAIN STATES MORTGAGE CENTERS INC., ITS SUCCESSORS AND ASSIGNS, as beneficiary, a certain Trust Deed dated 11/30/2009, duly recorded on 1/27/2010, as Instrument No. 2010-001017, and later modified by a Loan Modification Agreement recorded on 09/22/2015, as Instrument 2015-010443, in the mortgage records of Klamath County, Oregon.

In said Trust Deed the real property therein and hereinafter described was conveyed by said grantor to said trustee to secure, among other things, the performance of certain obligations of the grantor to the said beneficiary. The said grantor thereafter defaulted in his performance of the obligations secured by said Trust Deed as stated in the Notice of Default hereinafter mentioned and such default still existed at the time of the sale hereinafter described.

By reason of said default, the owner and holder of the obligations secured by said Trust Deed, being the beneficiary therein named, or his successor in interest, declared all sums so secured immediately due and owing; a Notice of Default, containing an election to sell the said real property and to foreclose said Trust Deed by advertisement and sale to satisfy grantor's said obligations was recorded in the mortgage records of said county on 3/29/2019, as Instrument No. 2019-003478 thereof, to which reference now is made.
