RECITALS: Linda M. David, An Unmarried Individual, as grantor, executed and delivered to First American Title Insurance Company of Oregon, as trustee, for the benefit of Pacific Crest Federal Credit Union, as beneficiary, a certain trust deed dated April 17, 2009, duly recorded on 2009. the April 24, in mortgage records of Klamath County.
