NOTICE TO RESIDENTIAL TENANTS

The property in which you are living is in foreclosure. A foreclosure sale is scheduled for **September 9**, **2019**. The date of this sale may be postponed. 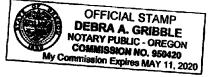
