KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto **Reynaldo Gonzales**, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

In construing this deed, where the context so requires, the singular includes the plural, and all grammatical changes shall be made so that this deed shall apply equally to corporations and to individuals.

IN WITNESS WHEREOF, the grantor has executed this instrument on **August 23, 2019**; if grantor is a corporation, it has caused its name to be signed and its seal, if any, affixed by an officer or other person duly authorized to do so by order of its board of directors.



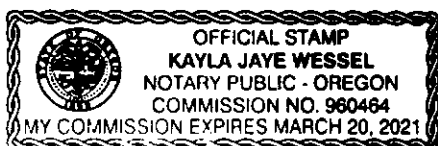

Beginning at an iron pin which marks the most Southerly corner of Lot 26, Lakewood Heights and the most Westerly corner of Lot 27, Lakewood Heights, and running thence: North  $10^{\circ}23'$  West a distance of 91.1 feet to an iron pin; thence South  $52^{\circ}32'$  East a distance of 93.5 feet to a point on the line between Lots 26 and 27 of Lakewood Heights; thence continuing South  $52^{\circ}32'$  East a distance of 7 feet to a point; thence South  $35^{\circ}28'$  East a distance of 25 feet to a point; thence South  $60^{\circ}10'$  West a distance of 79.2 feet to a point; thence North  $23^{\circ}28'$  West a distance of 13 feet to an iron pin; thence North  $10^{\circ}23'$  West a distance of 20.4 feet, more or less, to the point of beginning, said tract being a portion of Lots 26 and 27 of Lakewood Heights in Section 23, Township 38 South, Range 8 East, Willamette Meridian, Klamath County, Oregon.
