THIS INDENTURE Made this day of AUGUST 2019, by and between

TIMOTHY R. MCQUEARY, the duly appointed, qualified and acting personal

representative of the estate of ROSETTA E. HULL deceased, Probate Case No. 18PB08753, filed in Klamath County,

hereinafter called the first party, and

James Tyler Simington,

hereinafter called the second party;

WITNESSETH:

For value received and the consideration hereinafter stated, the receipt whereof hereby is acknowledged, the first party has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said second party and second party's heirs, successors-in-interest and assigns all the estate, right and interest of the said deceased at the time of the decedent's death, and all the right, title and interest that the said estate of said deceased by operation of the law or otherwise may have thereafter acquired in that certain real property situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Parcel 1 of Land Partition 35-92 situated in the NW1/4 of the SE1/4 of Section 22, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon.
