follows, to-wit:

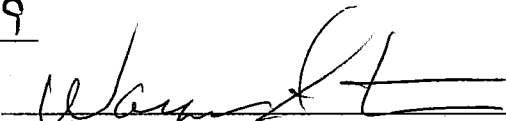

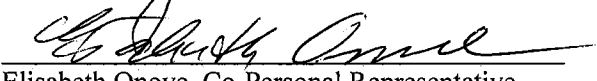
The true and actual consideration paid for this transfer, stated in terms of dollars is \$535,000.00. However, the actual

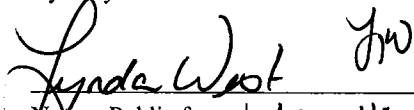

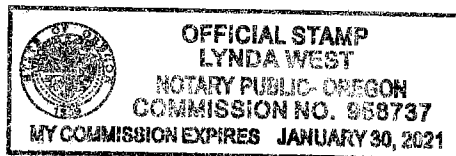

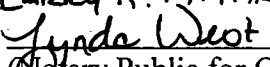
