ASSEMBLIES OF GOD, OREGON DISTRICT, a nonprofit corporation, GRANTOR, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto FAITH TABERNACLE OF KLAMATH FALLS, OREGON, an Oregon nonprofit corporation, dba Refuge City Church, GRANTEE, the following described real property free of encumbrances, except those of record, or as specifically set forth herein, situated in Klamath County, Oregon, described as follows, to-wit:

Lots 13, 14, 15, 16, 17 and 18 in Block "C", Railroad Addition to said City of Malin, Klamath County, Oregon, according to the duly recorded plat thereof; less thirty (30) feet off the southerly portion thereof next to Market Street and parallel with the northerly right-of-way line of said Market Street.

The true and actual consideration for this conveyance stated in terms of dollars is: \$None. This is a transfer from a nonprofit entity to an affiliated nonprofit entity and no monetary consideration is involved.

SUBJECT TO RE-VESTING IN GRANTOR UPON ANY ONE OR MORE OF THE FOLLOWING CONDITIONS SUBSEQUENT: If said property, or any portion of it, is at any time (a) not used as an Assembly of God Church affiliated and in good standing with the Assemblies of God, Oregon District, or its successor, ("District"), or (b) if Grantee or any of Grantee's successors ("Grantee") ceases to function as an Assemblies of God church affiliated with and in good standing with the District, or (c) if Grantee disaffiliates from the District by any means whatsoever, or (d) if Grantee fails at any time to qualify as exempt from federal income tax, or (e) Grantee is dissolved, then the property herein granted shall revert to and re-vest in the Grantor, or Grantor's successor. The determination as to whether or not any of the foregoing conditions subsequent have occurred shall be in the sole discretion of the District, which determination shall be final and binding on all parties, when evidenced by a document executed by the District, pursuant to a resolution of the District's presbytery, in the same manner as a deed, and recorded, shall be conclusive with respect to such issue.

ALSO SUBJECT to that certain Agreement for the establishment, ownership and operation of the subject property as an Assembly of God church by and between the Grantor and the Grantee, the terms and conditions thereof being on file with the District.
