The true and actual consideration for this conveyance is \$212,000.00.

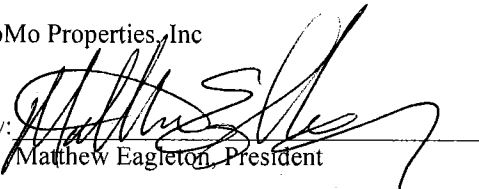

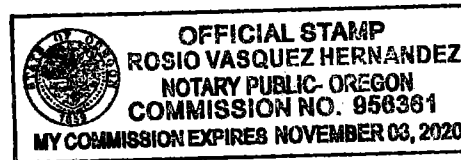

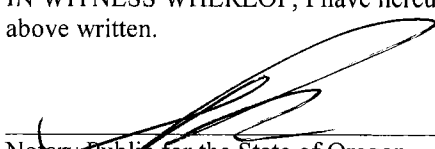
