hereinafter called Grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit:

An area of land in Government Lots 15, 17, 18, 23, 24, 25, 26, 31, and 32 of Section 13, Township 36 South, Range 10 East, of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

All of Government Lots 18, 23, 24, 25, 26, 31, and 32 of said Section, along with that portion of Government Lot 15 of said Section, lying Southerly of the centerline of Sprague River Highway and that portion of Government Lot 17 of said Section, lying Southerly of the South right-of-way of the Sprague River Highway.

The true and actual consideration paid for this transfer, stated in terms of dollars, is per Lot Line Adjustment PLA-2-19.

However, the actual consideration consists of or includes other property or value given or promised which is the whole / part of the consideration.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.
