RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 17CV17785, Klamath County Sheriff's Office Number F18-0213, in which JPMORGAN CHASE BANK, NATIONAL ASSOCIATION was plaintiff(s) and KATHY J. 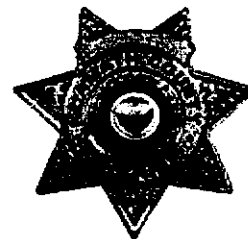

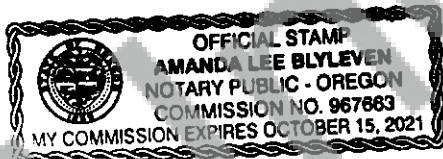
