KNOW ALL MEN BY THESE PRESENTS, That Timothy L. Perkins and Cassandra N. Perkins, who acquired title as Cassandra N. Beumeler, Not as Tenants in Common but with Right of Survivorship,

hereinafter called Grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto

Timothy L. Perkins and Cassandra N. Perkins, as Tenants by the Entirety,

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit:

A parcel of land lying in the NE1/4 SW1/4 of Section 36, Township 38 South, Range 9 East of the Willamette Meridian, more particularly described as follows:

Beginning at a point on the Easterly line of First Addition to Moyina, said point being North 0°16' West 120.0 feet from the Southeasterly corner of said First Addition to Moyina; thence North 0°16' West 85.86 feet along the Easterly line of said First Addition to Moyina to a point; thence North 89°44' East 120.0 feet to a point; thence South 0°16' East 85.86 feet to a point; thence South 89°44' West 120.0 feet to the point of beginning.
