TRUST DEED MODIFICATION

This Modification is entered into this 'th day of October, 2019, by and between Shandra Brown and Jared Smith and Atomic Lettuce, LLC (hereinafter "Grantors") and Roy Kaylor (hereinafter "Beneficiary"); and

WHEREAS, on the 8th day of May, 2017, Beneficiary loaned to Grantors Shandra Brown and Jared Smith the sum of Two Hundred Thousand Dollars (\$200,000.00), with interest thereon according to the terms of a promissory note of the same date, payable to Beneficiary, the final payment to be due and payable May 5, 2037, pursuant to the terms and conditions of a Trust Deed duly executed and recorded in the office of the County Clerk of Klamath County, Oregon, on the 8th day of May, 2017 (2017-004813); and described as follows:

Beginning at an iron pin which lies North 89°49' West along the quarter line a distance of 976.4 feet from the iron pin which marks the center of Section 7, Township 38 South, Range 9 East of the Willamette Meridian and running thence South 6.02" West a distance of 240.3 feet to an iron pin: thence North 89.49' West a distance of 708.6 feet top an iron pin which lies on the Easterly right of way line of the new Dalles-California Highway; thence North 11°36' West following the Easterly right of way line of the new Dalles-California Highway a distance of 244.18 feet to an iron pin; thence South 89°49' East along the quarter line a distance of 782.6 feet, more or less, to a point of beginning, said tract in the North half of the Southwest quarter of Section 7, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon.

WHEREAS, on the 22nd day of May, 2017, an addendum to the Trust Deed was duly executed; and

WHEREAS, Grantors desire to amend said Trust Deed; and

NOW THEREFORE, for and in consideration of the mutual promises contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the parties hereto agree as follows:

The Trust Deed, which incorrectly names Grantors as husband and wife, hereby 1. correctly identifies Grantors as mother and son.

- 2. In lieu of the monthly payment amount stated in the Promissory Note, the Grantors shall have the option, with Beneficiary's approval, to perform certain services for said address in lieu of the monthly dollar amount so stated, for a term agreed to by all parties, with the full stated monthly dollar amount being applied to the outstanding balance.
- 3. Beneficiary hereby consents to a transfer of the property to Atomic Lettuce, LLC, a business organization in which each of the individual Grantors are a member.
- 4. Atomic Lettuce, LLC shall be an additional Grantor under the Trust Deed and shall be bound by all the terms of the Trust Deed.

Except as hereinabove modified, the Trust Deed dated May 8, 2017 and the Addendum dated May 22, 2017, shall continue in full force and effect.
