

## EXHIBIT "A" LEGAL DESCRIPTION

That portion of the NW1/4 SW1/4 of Section 25, Township 23 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, described as follows:

Beginning at the Northwest corner of the NW1/4 SW1/4 of Section 25; thence East along the North boundary line of the NW1/4 SW1/4 a distance of 193 feet to an iron post, which is the point of beginning; thence East along said boundary line for a distance of 230 feet to the intersection of the Dalles-California Highway right of way; thence Southwesterly along said Highway right of way, for a distance of 108 feet; thence Northwesterly for a distance of 200 feet to the intersection of the North boundary line of the NW1/4 SW1/4 which is the point of beginning.
