

ARTICLE FOURTH

Distribution to Surviving Trustor

If either of the Trustors survives the other, then upon the death of the deceased Trustor, the Trustee shall set apart the assets referred to as Share B in Article THIRD above and shall distribute such property to the surviving Trustor or as the surviving Trustor shall direct.

If the surviving Trustor shall disclaim or renounce his or her interest in any property under this Article FOURTH, such property shall be held and disposed of in accordance with the provisions of Article FIFTH below, recognizing that the surviving Trustor, as the income beneficiary of the trust created pursuant thereto, shall be entitled to income therefrom.

ARTICLE FIFTH

Credit Shelter Trust

If, upon the death of the first of the Trustors to die, the deceased Trustor is survived by the other Trustor, the Trustee shall set apart and hold as a separate trust (the "Credit Shelter Trust") any property which the surviving Trustor shall have elected to disclaim or renounce as provided for in Article FOURTH above.

During the life of the surviving Trustor, the Trustee shall hold, manage, invest, and reinvest the assets of this Credit Shelter Trust, shall collect the income therefrom, and shall pay the net income to or for the benefit of the surviving Trustor, or apply the same for his or her benefit, in such shares as the Trustee in the absolute discretion of the Trustee may deem advisable, in convenient installments but at least annually. In addition, the Trustee may pay to or for the benefit of the surviving Trustor, for his or her health, education, maintenance, or support, any part or all of the principal of this trust, as the Trustee in the absolute discretion of the Trustee may deem advisable, without considering other resources available to the surviving Trustor. In exercising the discretionary power to pay income or principal, the Trustee shall give primary consideration to the surviving Trustor's needs and desires.

Upon the death of the surviving Trustor, the principal of this trust, as then constituted, shall be disposed of as provided in Article SIXTH hereof.

ARTICLE SIXTH

Successor Beneficiaries

After the death of the surviving Trustor, the trust estate at that time remaining shall be distributed in equal shares to the Trustor's children, by right of representation. If a child of the Trustors shall not be then alive and leaves no living descendants, their share shall lapse.

ARTICLE TWENTIETH

Short Name

This Agreement and the trusts created hereunder may be referred to, in any other instrument, by the name: "JR Morris Family Living Trust". Any transfers to this Agreement or any trust hereunder may refer to the aforesaid name or to "James Robert Morris and Robin Kennedy Morris as Trustees under James Robert Morris and Robin Kennedy Morris Living Trust" with or without specifying any change in Trustee or any amendment to this Agreement.
