## STATUTORY WARRANTY DEED

Grantor(s), hereby convey and warrant to

Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

A parcel of land situated in the S1/2 SE1/4 NW1/4 of Section 11, Township 39 South, Range 9 East of the Willamette Meridian, more particularly described as follows:

Beginning at an iron pin marking the Southeast corner of the SE1/4 NW1/4 of said Section 11, said point being the Northeast corner of "PERRY'S ADDITION TO LLOYDS TRACTS" subdivision; thence South 89°50' West along the South line of the S1/2 SE1/4 NW1/4 of said Section 11, said line being the North line of "PERRY'S ADDITION TO LLOYDS TRACTS" subdivision a distance of 141.90 feet to an iron pin on the Easterly right-of-way line of Hope Street; thence North 0°17' East along the Easterly line of Hope Street a distance of 376.43 feet to a point and the true point of beginning of the tract to be hereinafter described; thence North 89°50' East 142.61 feet, more or less, to the East line of the S1/2 SE1/4 NW1/4 of said Section 11; thence North 0°23'33" East along the East line of the S1/2 SE1/4 NW1/4 of said Section 11, 94 feet to a point; thence South 89°50' West 142.79 feet, more or less to a point on the East line of Hope Street; thence South 0°17' West along the East line of Hope Street 94 feet to the true point of beginning.
