Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

A parcel of land situated in the SW1/4 SE1/4 of Section 1, Township 39 South, Range 9 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows:

Beginning at a brass bolt on the intersection of the centerline of the Dalles-California Highway and the South line of said Section 1, said point being South 89° 56' West a distance of 17.90 feet from the Southwest corner of the SE1/4 SE1/4 of said Section 1 as shown on Survey No. 590 recorded in the office of the Klamath County Surveyor; thence North 46° 09' West along the centerline of said highway a distance of 356.00 feet; thence North 17° 48' West a distance of 63.18 feet to the intersection of the Southwesterly bank of the Enterprise Irrigation District canal and the Northeasterly right of way line of said highway; thence North 17° 48' West along the right of way line of the canal 358.00 feet to the true point of beginning of the description; thence South 43° 51' West 170.00 feet to the Northeasterly right of way line of the State Highway; thence North 46° 09' West along the highway right of way 110.00 feet; thence North 43° 51' East 209.77 feet to the Southerly right of way line of the irrigation canal; thence South 07° 58' West along the canal right of way 49.08 feet; thence South 17° 48' East along the canal right of way line 92.3 feet to the point of beginning, LESS any land lying inside the State Highway right of way.
