### **TERMINATION AND RELEASE OF LEASE**

1. Lease. A Geothermal Lease and Agreement dated on or about June 26, 2009, was entered into between OPTIM, INC., and SYDNEY K. GIACOMINI and CYNTHIA L. BARRETT. This lease was evidence by a Memorandum of Geothermal Lease and Agreement recorded November 18, 2010, as Document No. 2010-13393

2. Assignment of Lease Interest. On or about August 7, 2012, OPTIM, INC., unconditionally and absolutely assigned, set over, transferred and conveyed unto KLAMATH BASIN GEOPOWER, INC., a Nevada Corporation, all of Optim's (Lessee's) right, title and interest under the Lease. 


