THIS INDENTURE, Made this 10/02/2018, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and DONALD AND DORA SEAMAN, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 16CV32942, Klamath County Sheriff's Office Number F17-0171, in which FEDERAL NATIONAL MORTGAGE ASSOCIATION ("FANNIE MAE"), A CORPORATION ORGANIZED AND EXISTING UNDER THE LAWS OF THE UNITED STATES OF AMERICA was plaintiff(s) and MICHAEL D. SOWERS AKA MICHAEL DAVID SOWERS; JULIA M. 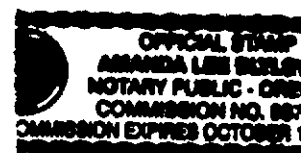
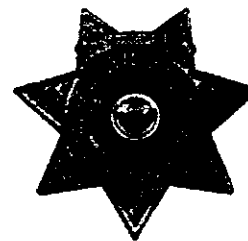
