Goossen**, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

**Description of real property:** The SE 1/4 of the SW 1/4 of Section 12, Township 39 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon.

**Subject to covenants, conditions, restrictions, easements, reservations, rights, rights of way and all matters appearing of record.**


To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.

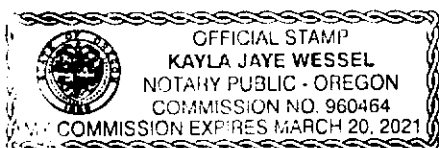


