TRUSTEE'S DEED UPON SALE

THIS INDENTURE, made **12/19/2019**, between **QUALITY LOAN SERVICE CORPORATION OF WASHINGTON**, (hereinafter "trustee"), and **Tom's Bronco Parts Retirement Plan**, (hereinafter "the second party"):

WITNESSETH:**RECITALS:**

MARK WISHART, as grantor, executed and delivered to **AMERITITLE**, for the benefit of **MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC., AS NOMINEE FOR NEW DAY FINANCIAL, LLC., ITS SUCCESSORS AND ASSIGNS**, as beneficiary, a trust deed dated **8/29/2018**, duly recorded on **8/30/2018**, in the mortgage records of **KLAMATH** County, Oregon, as fee/ file/ instrument/ microfilm/ reception number **2018-010571**. The interest in the trust deed has now been transferred to the foreclosing lender, the current Beneficiary. In said trust deed, the real property therein and hereinafter described ("Property") was conveyed by the grantor to the trustee to secure, among other things, the performance of the grantor's obligations to the beneficiary. The grantor thereafter defaulted in the performance of the obligations secured by the trust deed as stated in the notice of default hereinafter mentioned and such default still existed at the time of the sale hereinafter described.

Because of the default(s), the beneficiary under the trust deed or its successor in interest declared all sums secured by the trust deed immediately due and owing; therefore a notice of default, containing an election to sell the Property and to foreclose the trust deed by advertisement and sale to satisfy grantor's obligations owed to the beneficiary was recorded in the mortgage records of said county on **7/31/2019** as fee/ file/ instrument/ microfilm/ reception number **2019-008670**.

After recording the Notice of Default and at least 120 days before the date the property was sold, a copy of the Notice of Sale and a copy of the Danger Notice required by ORS 86.756 were served by **QUALITY LOAN SERVICE CORPORATION OF WASHINGTON** pursuant to ORCP 7D(2) and 7D(3) or mailed by both first class and certified mail with return receipt requested to the last known address of all required/interested parties in ORS 86.764. The undersigned trustee has no actual notice of any person, other than the persons named in said affidavits and proofs as having or claiming a lien on-or interest in said described real property, entitled to notice pursuant to ORS 86.764. The Notice of Sale was served upon the occupant of the property described in the trust deed pursuant to ORS 86.774(1). Pursuant to ORS 86.782(12), if the foreclosure proceedings were stayed and released from the stay, copies of an amended notice of sale were mailed by registered or certified mail to the last-known address of the persons listed in ORS 86.764 and 86.774(1), and all other persons required to receive the notice. Further, pursuant to ORS 86.774(2) the trustee published a copy of the notice of sale in a newspaper of general circulation in each of the counties where the property is located, once a week for four successive weeks, the last publication occurred at least 20 days prior to the date of the sale. 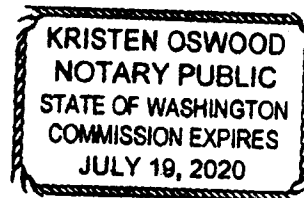
