THIS INDENTURE, made 01/30/2020, between The Mortgage Law Firm, LLC, hereinafter called trustee, and Reverse Mortgage Solutions, Inc., hereinafter called the second party;

WITNESSETH:

RECITALS: Patricia Howell, as Grantor, executed and delivered to Alan E. South, Attorney at Law, South & Associates, as Trustee, for the benefit of, Urban Financial Group, as Beneficiary, a certain Trust Deed dated 01/30/2009, duly recorded on 02/06/2009, in the mortgage records of Klamath County, Oregon, as Instrument No. 2009-001498. The interest in the trust deed was transferred to the foreclosing entity, Reverse Mortgage Solutions, Inc. in Klamath County, Oregon.

In said Deed of Trust the real property therein and hereinafter described was conveyed by said grantor to said trustee to secure, among other things, the performance of certain obligations of the grantor to the beneficiary. The grantor thereafter defaulted in the performance of the obligations secured by the trust deed as stated in the notice of default hereinafter mentioned and such default still existed at the time of the sale hereinafter described.

promptly after the trustee received knowledge of the disability, insanity or death of any such person; the Notice of Sale was served upon occupants of the property described in the trust deed in the manner in which a summons is served pursuant to ORCP 7D.(2) and 7D.(3) at least 120 days before the date the property was sold, pursuant to ORS 86.774(1). If the foreclosure proceedings were stayed and released from the stay, copies of an Amended Notice of Sale in the form required by ORS 86.782(12) was mailed by registered or certified mail to the last-known address of those persons listed in ORS 86.764 and 86.774(1) and to the address proved by each person who was present at the time and place set for the sale which was stayed within 30 days after the release from the stay. Further, the trustee published a copy of said notice of sale in a newspaper of general circulation in each county in which the said real property is situated, once a week for four successive weeks; the last publication of said notice occurred more than twenty days prior to the date of such sale.
