WHEREAS, the Klamath County Planning Department provided written notice of the public hearing as required in Klamath County Land Development Code Article 31; and

WHEREAS, a quasi-judicial public hearing was held on January 28, 2020, and a Staff Report was provided, and public testimony was considered before the Klamath County Planning Commission and Board of County Commissioners; and

WHEREAS, based on testimony entered and in consideration of the whole record, the Klamath County Planning Commission accepted the Applicant's responses to each criterion provided in the Burden of Proof as findings of fact and found the application met the criterion set forth in OAR 660-023, recommended approval of amending the Comprehensive Plan and adding the property to the Significant Resource Overlay on the Zoning Map, and, said recommendation was forwarded to the Klamath County Board of Commissioners; and

WHEREAS, the Klamath County Board of Commissioners voted to approve the Planning Commission recommendation to grant the exception and add the Limited Use Overlay to the subject property; and

NOW, THEREFORE, the Klamath County Board of Commissioners ordains the Planning Commission recommendation to amend the Goal 5 Inventory of the Comprehensive Plan and add the property to the Significant Resource Overlay on the Zoning Map; and
