The above-described property is free of encumbrances except all those items of record, if any, as of the date of this deed and those shown below, if any:

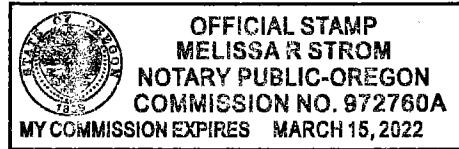
