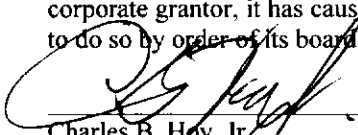

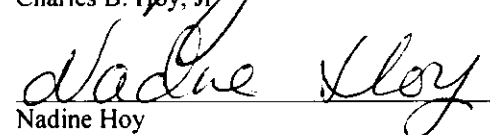
The true and actual consideration paid for this transfer, stated in terms of dollars, is Creation of parcel.

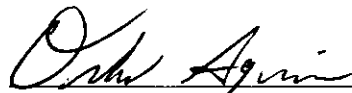
