To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.

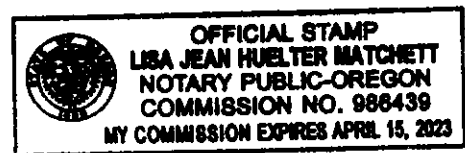

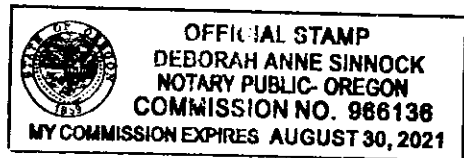


EXHIBIT "A"

A portion of Lots 14, 15 and 16 of "Merrill Tract", situated in the NE1/4 SE1/4 of Section 2, Township 41 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a point on the North line of said Lot 14, from which the Northeast corner of said Lot 13 bears N89°46'46"E 520.51 feet; thence, leaving said North line, S25°45'30"W 299.41 feet to a point on the Northeasterly right of way line of the BNSF Railroad; thence, along the said Northeasterly right of way, on the arc of a curve to the right (radius point bears N25°09'14"E 2839.79 feet and central angle equals 10°39'07") 527.95 feet to a point on the North line of said Lot 16; thence N89°46'46"E, along the North line of said Lots 16, 15 and 14, 584.46 feet to the point of beginning, containing 1.91 acres, more or less.
