Lot 4 in Block 9 of Tract No. 1025, WINCHESTER, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

The true and actual consideration paid for this transfer, stated in terms of dollars, is to convey title.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.
