MEMORANDUM OF UNITARY MASTER LEASE

This MEMORANDUM OF UNITARY MASTER LEASE ("Memorandum"), is made and executed as of the 9th day of June, 2020 (the "Effective Date"), by and between ACI REAL ESTATE SPE 127, LLC, a Delaware limited liability company ("Landlord"), whose address is c/o Albertsons Companies, 250 Parkcenter Boulevard, Boise, ID 83726, Attn: Legal Department, and ACI REAL ESTATE COMPANY LLC, a Delaware limited liability company ("Tenant"), whose address is c/o Albertsons Companies, 250 Parkcenter Boulevard, Boise, ID 83726, Attn: Legal Department.

RECITALS:

- A. Landlord and Tenant entered into that certain Unitary Master Lease, dated as of June 9, 2020 (the "Lease"), covering, in addition to other properties, that certain property located in Klamath Falls, Oregon, as more particularly described on <u>Schedule I</u> attached hereto and incorporated herein by this reference together with all buildings and improvements located thereon and all easements, rights and appurtenances thereto (the "Leased Premises").
- B. Landlord and Tenant have agreed to enter into this Memorandum for the purposes of providing record notice of the Lease, to set forth certain of the terms and conditions of the Lease, and to protect the rights and interests of Landlord and Tenant as to third parties. All capitalized terms not specifically defined herein shall have the meaning ascribed to such terms in the Lease.
- NOW, THEREFORE, for and in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Landlord and Tenant hereby agree as follows:
- 1. <u>Lease and Premises</u>. Subject to the covenants and conditions contained in the Lease, Landlord has leased to Tenant, and Tenant has leased from Landlord, the Leased Premises.

- 2. <u>Term; Rent Commencement Date</u>. The term of the Lease commenced on June 9, 2020 ("<u>Rent Commencement Date</u>") and expires on the twentieth (20th) anniversary of the last day of the month in which the Rent Commencement Date occurred, unless such term is reset in accordance with the terms set forth in Section 2.1 of the Lease or is otherwise earlier terminated pursuant to the terms of the Lease. The term of the Lease may be extended for eight (8) consecutive periods of five (5) years each, subject to the terms set forth in Section 2.2 of the Lease.
- 3. <u>Conflict</u>. This Memorandum is prepared for the purpose of constructive notice and in no way modifies the provisions of the Lease. In the event of any conflict or any inconsistency between the terms and provisions of the Lease and the terms and provisions of this Memorandum, the terms and provisions of the Lease shall control. Nothing contained in this Memorandum shall alter, modify or amend the provisions of the Lease (or the exhibits thereto), which remain in full force and effect according to all of the terms and provisions thereof.
- 4. <u>Successors and Assigns</u>. This Memorandum shall be binding upon and inure to the benefit of the parties and their permitted successors and assigns.
- 5. <u>Counterparts</u>. This Memorandum may be executed in one or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same document, provided that all parties are furnished a copy thereof reflecting the signature of all parties.
