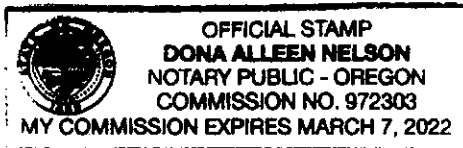



**NOTICE OF DEFAULT AND ELECTION TO SELL**

KNOW ALL MEN BY THESE PRESENTS, that ROBERT HILL and AMY HILL, is the grantor and AMERITLE, an Oregon Corporation, is the trustee and RICHARD LOUCH as to an undivided 1/2 interest and HOWARD LOUCH as to an undivided 1/2 interest, is the beneficiary under that certain deed December 10, 2015, and recorded on December 16, 2015, as Instrument No. 2015 at page 013529 of the Mortgage (Microfilm) Records of Klamath County, Oregon. Both the beneficiary and the trustee have elected to sell the said real property to satisfy the obligations secured by said trust deed and a Notice of Default has been recorded pursuant to Section 86.735(3) of Oregon Revised Statutes. The Default for which said foreclosure is made is grantor's failure to pay when due the following sums:

Failure to make monthly payments in the amount of \$400.00. per month from March 16, 2019 through the present.

Failure to pay real property taxes for the 2017-2018 tax year in the amount of \$686.48 plus interest.

Failure to pay real property taxes for the 2017-2018 tax year in the amount of \$686.68 plus interest.

Failure to pay real property taxes for the 2019-2020 tax year in the amount of \$764.07 plus interest.

Failure to pay real property taxes for the 2019-2020 tax year in the amount of \$779.20 plus interest.

By reason of said default, the beneficiary has declared all sums owing on the obligation secured by said trust deed immediately due and payable, said sums being the following to-wit: \$927.36 as of February 28, 2019 plus interest and costs.

#### NOTICE TO POTENTIAL PURCHASERS

Without limiting the trustee's disclaimer of representations or warranties, Oregon law requires the trustee to state in this notice that some residential property sold at a trustee's sale may have been used in manufacturing methamphetamines, the chemical components of which are known to be toxic. If you have a fixed term lease, you may be entitled to receive after the date of sale a 60 day notice of the purchaser's requirement that you move out. To be entitled to a 30 day or 60 day notice, you must give the trustee of the property written evidence of your rental agreement at least 30 days before the date first set for the sale. If you have a fixed term lease, you must give the trustee a copy of the rental agreement. If you do not have a fixed term lease and cannot provide a copy of the rental agreement, you may give the trustee other written evidence of the existence of the rental agreement. The date that is 30 days before the date of the sale is June 6, 2020. The Name of the trustee and the trustee's mailing address are listed on this notice. Federal law may grant you additional rights including a right to a longer notice period. Consult a lawyer for more information about your rights under federal law. You have the right to apply your security deposit and any prepaid rent toward your current obligations under your rental agreement. If you want to do so, you must notify your landlord in writing and in advance that you intend to do so. If you believe you need legal assistance with this matter, you may contact the Oregon State Bar and ask for the lawyer referral service. The Oregon State Bar attorney referral service may be reached at (800) 452-7636. If you have a low income and meet federal poverty guidelines, you may be eligible for free legal assistance. Legal Aid may be reached at (800) 489-9160.

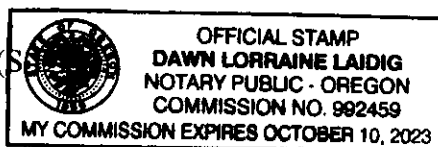


