BEGINNING AT A POINT ON THE EAST LINE OF SAID LOT 8 FROM WHICH THE NORTHEAST CORNER OF SAID LOT 8 BEARS N00°00'38"W 7.19 FEET; THENCE LEAVING SAID EAST LINE N86°34'52"W 3.62 FEET; THENCE N18°22'05"E 7.35 FEET TO A POINT ON THE NORTH LINE OF SAID LOT 8; THENCE ALONG THE NORTH LINE N89°59'22"E 1.30 FEET TO THE NORTHEAST CORNER OF SAID LOT 8; THENCE ALONG THE EAST LINE S00°00'38"E 7.19 FEET TO THE POINT OF BEGINNING, CONTAINING 17 SQUARE FEET, MORE OR LESS WITH BEARINGS BASED ON RECORD OF SURVEY # 2510 ON FILE IN THE OFFICE OF THE KLAMATH COUNTY SURVEYOR.

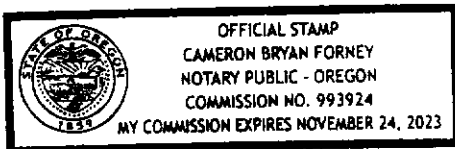
