THIS INDENTURE, Made this 08/04/2020, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and PENNYMAC LOAN SERVICES, LLC, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 18CV36541, Klamath County Sheriff's Office Number F19-0296, in which PENNYMAC LOAN SERVICES, LLC was plaintiff(s) and UNKNOWN HEIRS, DEVISEES AND/OR SUCCESSORS IN INTEREST OF DARRYL D. SISTO; RANDI K. 
