MEMORANDUM OF LEASE

This MEMORANDUM OF LEASE (this "Memorandum") is made and entered into effective as of May 2020 ("Effective Date"), between SHANDA ASSET MANAGEMENT LLC ("Lessor"), a Delaware limited liability company (formerly known as Whitefish Cascade Forest Resource LLC) with an address of 56880 Venture Lane, Suite 203N, Bend, OR 97707, and SPRING BUTTE ROCK, LLC ("Lessee"), an Oregon limited liability company with an address of PO Box 2806 La Pine, OR 97739. Lessor and Lessee are sometimes referred to in this Memorandum collectively as the "Parties."

Notice is hereby given that the Parties have executed that certain Hard Rock Mining Lease, dated effective concurrent with the Effective Date, pursuant to which Lessor (A) leased, and hereby leases to Lessee certain lands in Klamath County, Oregon, more particularly described in attached Exhibit A ("Property") for the following purposes: (i) exploring the Property for hard rock by any method, including without limitation (1) by geochemical, geophysical and geological methods, (2) drilling, trenching and other surface and subsurface activities, and (3) taking and keeping samples (including bulk samples) for testing; (ii) mining of hard rock; (iii) crushing, washing, grading, sorting, stockpiling, loading, and transporting hard rock mined from the Property; and (iv) for similar activities incidental to the exploration and mining of hard rock from the Property (collectively, the "Lease Rights"); and (B) granted, and hereby grants, to Lessee the non-exclusive right to use the surface of other property owned by Lessor and adjacent to the Property for purposes of accessing the Property. Lessee has exclusive rights to the Lease Rights granted under the Lease.

The initial term of the Lease commences on the Effective Date and terminates at midnight on the twenty-fifth (25th) anniversary of the Effective Date with Lessee having the option to extend the Lease for two (2) additional periods of twenty (20) years each.
