of Klamath County, Oregon.**

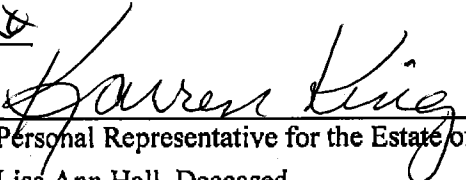
