KNOW ALL BY THESE PRESENTS this deed, made this 21st day of September, 2020, between Rick Vaughn, TAX COLLECTOR, Klamath County, State of Oregon, "Grantor", and KLAMATH COUNTY, a Political Subdivision of the State of Oregon, "Grantee".

RECITALS

Pursuant to ORS 312.100 the said properties on the list attached hereto as "Exhibit B" were ordered sold to Klamath County, Oregon, subject to the right of redemption as provided by law. A General Judgment was entered in the Circuit Court of the State of Oregon for the County of Klamath on September 18, 2018. Case No. 18CV36633 in favor of Klamath County, Oregon, and against Agard Patricia, Agard Timothy Dwayne Roy, et al.

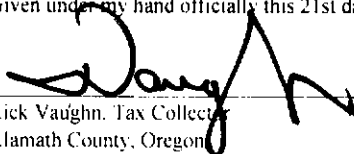

The properties were not redeemed as provided by law.

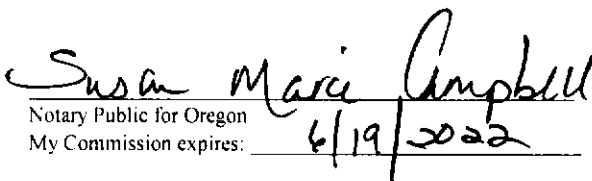
