SUBORDINATION AGREEMENT

1. **UMPQUA BANK** referred to herein as "subordinator", is the owner and holder of a deed of trust dated **October 11, 2019** which is recorded on **Ocotber 28, 2019** in the amount of **\$120,000.00** under auditor's file No **2019-012528**, records of **Klamath County** executed by **Randal G. Hunter and Judy C. Hunter**.

2. Umpqua Bank referred to herein as "lender" is the owner and holder of the deed of trust dated 9-15-2020, in the principal amount of up to **\$134,500.00** together with interest on such indebtedness according to the terms of the Note executed by Randal G. Hunter and Judy C. Hunter under auditor's file No 2020-012380, records of **Klamath County** (which is to be recorded concurrently herewith).

3. Randal G. Hunter and Judy C. Hunter, referred to herein as "owner," is the owner of all the real property described in the deed of trust identified above in Paragraph 2.

4. In consideration of benefits to "subordinator" from "owner", receipt and sufficiency of which is hereby acknowledged, and to induce "lender" to advance funds under its deed of trust and all agreements in connection therewith, the "subordinator" does hereby unconditionally subordinate the lien of the deed of trust identified in Paragraph 1 above to the lien of "lender's" deed of trust identified in Paragraph 2 above, and all advances or charges made or accruing hereunder, including any extension or renewal thereof.

5. "Subordinator" acknowledges that, prior to the execution hereof, he has had the opportunity to examine the terms of "lender's" deed of trust, note and agreements relating thereto, consents to and approves same, and recognizes that "lender" has no obligation to "subordinator" to advance any funds under its deed of trust or see to the application of "lender's" deed of trust funds, and any application or use of such funds for purposes other than those provided for in such deed of trust, note or agreements shall not defeat the subordination herein made in whole or in part.

6. It is understood by the parties hereto that "lender" would not make the loan secured by the deed of trust in Paragraph 2 without this agreement.

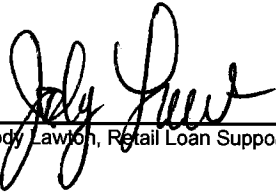

This agreement shall be the whole and only agreement between the parties hereto with regard to the subordination of the lien or charge of the deed of trust first above mentioned to the lien or charge of the mortgage in favor of "lender" above referred and shall supersede and cancel any prior agreements as to such, or any, subordination including, but not limited to, those provisions, if any, contained in the deed of trust first above mentioned, which provide for the subordination of the lien or charge thereof to a deed of trust or deeds of trust to be thereafter executed.

8. The heirs, administrators, assigns and successors in interest of the "subordinator" shall be bound by this agreement.

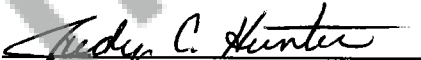

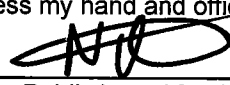

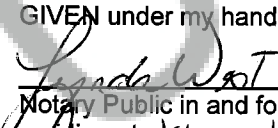
