KNOW ALL MEN BY THESE PRESENTS, That

Roxanne Payne and Kennedy Payne, Successor Co-Trustees of The Paul and Marilyn Hoefler Joint Revocable Living Trust dated May 28, 2004, doing business as Hoefler Bros

hereinafter called Grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto

## Hoefler Brothers, LLC, an Oregon Domestic Limited Liability Company

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit:

A portion of the Northeast quarter of the Northeast quarter (NE1/4 NE1/4) of Section 35, Township 38 South, Range 11 1/2 East of the Willamette Meridian, Klamath County, Oregon, described as follows: beginning at the point where the Westerly line of the Yonna Valley Market Road intersects the Northerly line of Section 35, Township 38 South, Range 11 1/2 East, Willamette Meridian; thence Westerly 50 feet; thence Southerly 50 feet; thence Easterly 50 feet; thence Northerly 50 feet to the point of beginning.

The true and actual consideration paid for this transfer, stated in terms of dollars, is -0-. However, the actual consideration consists of or includes other property or value given or promised which is the whole / part of the consideration.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.
