STATUTORY WARRANTY DEED

Jana M. French,

Grantor(s), hereby convey and warrant to

David Stanley Settle and Diana Jean Masters, with right of survivorship,

Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

Beginning at the iron pin which marks the Southwest corner of Lot 41, ELMWOOD PARK, Klamath County and running thence South 89°33' East along the South line of Lots 41 and 42 of Elmwood Park, a distance of 145 feet to an iron pin which lies on the Westerly right of way line of South Etna Street; thence in a Southerly direction along the Westerly right of way line of South Etna Street following the arc of an 88.3835 degree curve to the left, a distance of 64.37 feet to an iron pin; note the long chord of this curve bears South 28°30' East a distance of 61.86 feet; thence continuing South 57°00' East along the Southerly right of way line of South Etna Street a distance of 84.73 feet to an iron pin; thence continuing along the Southerly right of way line of South Etna Street following the arc of a 49.1072 degree curve to the right a distance of 96.05 feet to an iron pin which lies on the Northerly right of way line of the U.S.R.S. Lateral, note the long chord of this curve bears South 23°55' East a distance of 94.60 feet; thence following the Northerly right of way line of the U.S.R.S. Lateral in a Westerly direction to its intersection with the line between Lots 41 and 40 of Elmwood Park extended South; thence North along the line of Lots 41 and 40 of Elmwood Park, extended South, a distance of 159 feet, more or less, to the point of beginning, in the Southwest quarter of the Northwest quarter of Section 14, Township 39 South, Range 9 East of the Willamette Meridian.

The true and actual consideration for this conveyance is \$315,000.00.
