Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

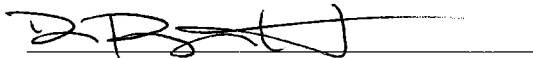

The true and actual consideration for this conveyance is \$182,000.00.

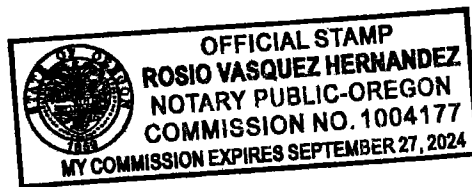

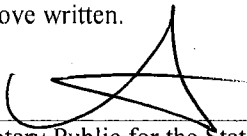
