Beginning at the Northwest corner of Lot 9, in Section 15, Township 41 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon; thence Easterly 20 chains along the North line of Lot 9 to the Northeast corner thereof; thence continuing Easterly along the North line of Lot 7 for 20 chains to the Northwest corner of Lot 3; thence South along the line between Lots 2 and 3 and between Lots 6 and 7 to the Southeast corner of said Lot 7; thence Northwesterly along the meander line of Tulelake and said Lots 7 and 9 to the Section line between Sections 15 and 16; thence North to the place of beginning, all in Section 15, Township 41 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon.

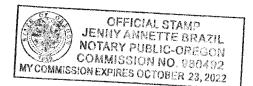
