TERMINATION OF GROUND LEASE AND NOTICE OF TERMINATION

This Termination of Ground Lease ("Memorandum") is effective as of the 1st day of October, 2020 between Klamath Housing Authority, an Oregon housing authority ("Lessor"), and Trails View LLC, an Oregon limited liability company ("Lessee"), with respect to that certain Ground Lease ("Ground Lease") dated as of June 1, 2010, between Lessor and Lessee, relating to the real property described on Exhibit A which is attached hereto and incorporated herein by reference (the "Real Property"). A Memorandum of Ground Lease relating to the Real Property was recorded in the deed records of Klamath County on September 10, 2010 as Instrument Number 2010-010796.

Lessor has acquired all of the member interests in Lessee as of October 1, 2020 and both Lessor and Lessee desire to terminate the Ground Lease as of October 1, 2020. Therefore, Lessor and Lessee agree that the Lease is terminated as of such date and shall be of no further force or effect. All right, title and interest in the Real Property, which is the subject of the Ground Lease, shall reside in the Lessor and the Lessee shall have no further right, title or interest in the Real Property or any improvements on such Real Property.

WHEREFORE, the parties have executed this Termination of Ground Lease and Notice of Termination as of the date first herein above written.

The land which constitutes the Premises of the Ground Lease is situated in the State of Oregon, County of Klamath and is described as follows:

A parcel of land situated in the NE ¼ of the SE ¼ of Section 3, Township 39 South, Range 9 East, Willamette Meridian, County of Klamath, State of Oregon, more particularly described as follows:
