KNOW ALL MEN BY THESE PRESENTS, That Valeria S. Menke, hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Valeria S. Menke), Trustee of the Valeria Martin-Menke REVOCABLE LIVING TRUST hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

LOT 4 AND THE NORTHWESTERLY ONE-HALF OF LOT 5 IN BLOCK 9 OF HILLSIDE ADDITION TO THE CITY OF

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.

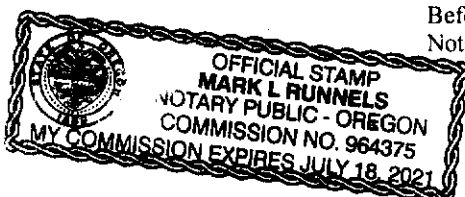
