Lot 1 of TRACT 1386, VALE HEIGHTS, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

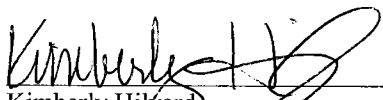

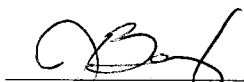
