Real estate situate in the county of Klamath, State of Oregon, described as follows: Beginning at a point on the section line between Section 26 and Section 35, Township 34 South, Range 6 East of the Willamette Meridian, 675.7 feet West of the 1/4 Section corner; thence South along the West line of the NE1/4 NE1/4 of the NW1/4, Section 35 and of the N1/2 SE1/4 NE1/2 NW1/4 of Section 35, a distance of 990 feet; thence East on the South line of the N1/2 SE1/4 NE1/4 NW1/4, Section 35 a distance of 530 feet; thence North a distance of 330 feet; thence West a distance of 135 feet; thence North a distance of 660 feet to intersect the above mentioned section line 395 feet East of point of beginning, thence West 395 feet to the point of beginning.
