Beginning at a point which lies North 89°06' East a distance of 30 feet and South 0°54' East along hte East line of right of way of Patterson Street, a distance of 900 feet from the iron pin which marks the Northwest corner of the SE1/4 SW1/4 of Section 1 in Township 39 South, Range 9, East of the Willamette Meridian, Klamath County, Oregon, and running thence North 89°06' East 210 feet to a point; thence South 0°54' East a distance of 100 feet to a point; thence South 89°06' West at right angles to the said East line of Patterson Street, a distance of 210 feet to a point on the said East line of said Patterson Street; thence North along the said East line of Patterson Street a distance of 100 feet to the point of beginning.

The true and actual consideration for this conveyance is \$153,500.00.


