#### PARCEL ONE

Beginning at an iron pin on the Easterly right of way line of the Rocky Point Road which makes the Northwest corner of Lot 26, FRONTIER TRACTS, a platted portion of Klamath County, Oregon; thence North 89°7' East along the Northerly line of said Lot 26 a distance of 58.38 feet to an iron pin; thence North 0°25' East 55 feet to an iron pin; thence Westerly and parallel to the Northerly line of said Lot 26 to the Easterly right of way line of Rocky Point Road; thence South 20°55' East along the Easterly right of way line of said Rocky Point Road to the point of beginning, being a portion of the W1/2 of Section 10, Township 36 South, Range 6 East of the Willamette Meridian, in the County of Klamath, State of Oregon.

### PARCEL TWO
