## QUITCLAIM DEED

Detroit, Grantors, release, quitclaim, and assign to Skyline View District Improvement Company, an Oregon Not For Profit Corporation, Grantee, all right, title, and interest we may have as owners of the westerly 165 feet of Lot 38, Piedmont Heights, Klamath County, Oregon, in and to the proceeds from the sale of the Skyline View District Improvement Company, its wells, land, and other improvements, and any other rights we may have arising under the provisions of Section 2, Article IV of the Bylaws for the Regulation of Skyline View District Improvement Company.

This Deed is made for the purpose of quieting title to the operation, revenue, sales proceeds, and all assets and liabilities of the Grantee, and to provide for Grantee to obtain financing for improvements to the well and water distribution system, which will be to the substantial benefit of the Grantors.

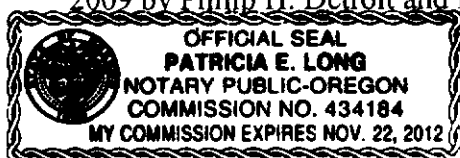
