hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit:

Those Parts of Lots 8 and 9 and 10, Block 2, HOMELAND TRACTS, lying Easterly of Enterprise Irrigation Canal, Klamath County, Oregon.
