The true and actual consideration paid for this transfer, stated in terms of dollars, is \$to convey title .

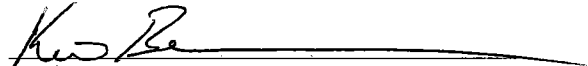
However, the actual consideration consists of or includes other property or value given or promised which is the whole / part of the consideration.

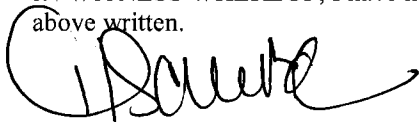
