The true and actual consideration for this conveyance is \$155,000.00.

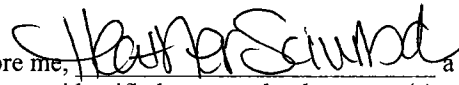

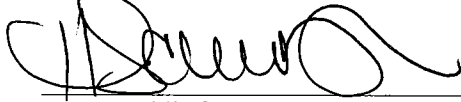
