A portion of the E1/2 of the SW1/4 of Section 33, Township 40 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a point on the West line of Drazil Road formerly Turkey Hill Road, which point lies 2044 feet, more or less, South and 30 feet, more or less, West of the Northeast corner of the E1/2 of the SW1/4 of Section 33, Township 40 South, Range 12 East of the Willamette Meridian, said point of beginning is also the point of intersection of Drazil Road and irrigation ditch running through said Section 33; thence North along said county road 358 feet; thence West 569 feet, more or less, to the center of the irrigation ditch; thence following centerline of said ditch in a Southeasterly direction to the point of beginning.
